**Note:** Affiliated units of Tripura and Punjab and Mr. Sudhir Kumar of Kerala sent email expressing inability to attend Special General Body Meeting fixed for today due to certain reasons.

The meeting was started by the Administrator and a round of introduction took place. The Administrator expressed concern about the absent member units, who opted not to remain present in the meeting which was called to finalise the Calendar for 2019-2020. They did not send any intimation for non-participation. No compelling reasons were communicated for absence to the Administrator.

The Agenda items were taken up for consideration.

### **Item No. 1 Finalization of Calendar of 2019-2020 and decision on National Championships**

### **A. Sub Junior National Kabaddi Championship**

Mr. S.S. Lakkad of M.P Amateur Kabaddi Association voluntarily proposed to organise Sub Junior National Kabaddi Championship for Boys & Girls at Indore/Ujjain/Harda in the last week of January 2020. Mr. S.S. Lakkad of M.P Amateur Kabaddi Association also requested for Grant-In-Aid for the same from AKFI. No other proposal by any other unit for Sub Junior National Kabaddi Championship was put before the house. The house unanimously decided to allot Sub Junior National Kabaddi Championship to M.P Amateur Kabaddi Association

### **B. Junior National Kabaddi Championship**

Mr. Krishna Lal Panwar of Amateur Kabaddi Association Haryana voluntarily proposed to organise Junior National Kabaddi Championship for Boys & Girls at Gurgaon/Panchkulla/Sonipat from 20 to 23 February 2020. Mr. Krishna Lal Panwar of Amateur Kabaddi Association Haryana informed that they did not need Grant-In-Aid from AKFI. No other proposal by any other unit for Junior National Kabaddi Championship was put before the house.

The house unanimously decided to allot Junior National Kabaddi Championship to Amateur Kabaddi Association Haryana.

### **C. Senior National Kabaddi Championship**

Mr. Tejasvi Singh of Rajasthan State Kabaddi Association voluntarily proposed to organise Senior National Kabaddi Championship for Men & Women at Jaipur in the month of March 2020. Mr. Tejasvi Singh of Rajasthan State Kabaddi Association informed that they did not need Grant-In-Aid from AKFI. No other proposal by any other unit for Senior National Kabaddi Championship Men & Women was put before the house. The house unanimously decided to allot Senior National Kabaddi Championship for Men & Women to Rajasthan State Kabaddi Association.

### **D. Federation Cup Junior**

Mr. Rajesh Singh of UP Kabaddi Association voluntarily proposed to organise Federation Cup Junior for Boys and Girls at Sonbhadra in the month of March 2020. Mr. Rajesh Singh of UP Kabaddi Association informed that they need Grant-In-Aid from AKFI. No other proposal by any other unit for Federation Cup Junior for Boys & Girls was put before the house. The house unanimously decided to allot Federation Cup Junior for Boys & Girls to UP Kabaddi Association.

### **E. Federation Cup Senior**

Mr. Niranjan Singh of Delhi State Kabaddi Association voluntarily proposed to organise Federation Cup Senior for Men and Women at Delhi in the month of March 2020. Mr. Niranjan Singh Delhi State Kabaddi Association informed that they did not need Grant-In-Aid from AKFI. No other proposal by any other unit for Federation Cup Senior for Men & Women was put before the house. The house unanimously decided to allot Federation Cup Senior for Men & Women to Delhi State Kabaddi Association.

### **F. Beach Kabaddi National Championship**

Mr. Chetan Joshi of Uttarakhand Kabaddi Association voluntarily proposed to organise Beach Kabaddi National Championship in Uttarakhand. Mr. Chetan Joshi of Uttarakhand Kabaddi Association informed that they need Grant-In-Aid from AKFI. No other proposal by any other unit for Beach Kabaddi National Championship was put before the house.

The house unanimously decided to allot Beach Kabaddi National Championship to Uttarakhand Kabaddi Association.

## **G. Circle Style Kabaddi National Championship**

Mr. Sikandar Singh Maluka of Punjab Kabaddi Association informed on phone that due to some unavoidable circumstances, the representative of Punjab Kabaddi Association could not reach Delhi to attend the meeting and requested to allot Circle Style Kabaddi National Championship to Punjab Kabaddi Association.

The matter was discussed in the house and house unanimously decided to allot Circle Style Kabaddi National Championship to Punjab Kabaddi Association.

### **Item No. 2 Any other matter with the permission of the chair**

Mr. Kuldeep Dalal of Amateur Kabaddi Association Haryana sought permission of the Chair to put forward his suggestions regarding referee exams, the permission was granted by the chair. Mr. Dalal requested that the examination centres be allotted if more than 20 candidates enrol to take exam from a particular state. The matter was discussed in the house and most of the member also requested to extend the date of Exam. It was unanimously decided that the date be extended and centres will be created wherever candidates are more than 20.

The Administrator also informed the house that every State has to send data of its State Championships as it is required by SAI-GOI for ACTC. All the member units present assured to send the data.

Chandigarh, Pondicherry, J&K and Uttarakhand associations requested the Administrator to issue affiliation certificates as the same is needed by them to give to various authorities. Administrator assured them that the same will be issued.

As there was no other matter the meeting closed with vote of thanks to the Chair.
