ORDER

- This order shall dispose of representation dated 30.03.2019 sent by Mr. Y. Srikanth claiming himself to be Honorary Secretary of Andhra Kabaddi Association, State of Andhra Pradesh.
- 2. In the representation the applicant Mr. Y. Srikanth has prayed to issue affiliation and recognition to Andhra Kabaddi Association represented by him as its General Secretary and Mr. G. Venkata Reddy as its President. It is stated that Returning Officer had issued election schedule for election of Andhra Kabaddi Association represented by him and the results were declared on 23.03.2019. The said elections were conducted by Justice DSR Verma Former Judge Andhra Pradesh High Court and Allahabad High Court as per order dated 17.01.2019 passed by the Administrator.
- 3. I have considered and examined the representation made by Mr. Y. Srikanth. It is relevant to note that pursuant to the judgment of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 dated 03.08.2018, names of two representatives were called from the

affiliated units for preparation of "Electoral College" to amend the MOA of AKFI and thereafter to conduct elections of the Office Bearers of AKFI. In response to the call, two names were received from Andhra Kabaddi Association (AKA), an affiliated State Association of AKFI namely V. Veeralankaiah Honorary Secretary and Mr. K.E Prabhakar President of the Association. Objections were called against those two nominations. Mr. K.P. Rao former Office Bearer of the Association filed objections to it. The objections were heard on 22.12.2018, Mr. K.P. Rao appeared in person assisted by his advocate Mr. A. Ushi Reddy. The petitioner Mr. Yalamanchili Srikanth informed that Mr. A. Ushi Reddy advocate had represented him as he had deputed him for hearing due to language problem.

It is further relevant to note that the parties were given two weeks time to file documents if any in support of their respective contentions. Pursuant to that the rejoinder dated 05.01.2019 and letter dated 08.01.2019 were received from the petitioner Yalamanchili Srikanth. These objections were decided by a comprehensive order dated 17.01.2019 and its intimation was given to all the objectors by e-mail. The order was also put up on the website

of the AKFI on the same day. Apparently objections/representations pending before the Administrator on 17.01.2019 were taken into consideration. In the said order it was specifically observed that for the purpose of conducting first round of election to elect Office Bearers to amend MOA of AKFI, the names sent by Andhra Kabaddi Association (AKA) that is Mr. V. Veeralankaiah and Mr. K.E Prabhakar are to be accepted. The Andhra Pradesh Kabaddi Association led by both these Office Bearers continues to be the affiliated unit of AKFI till date. The Andhra Kabaddi Association being led by Mr. Yalamanchili Srikanth as Honorary Secretary has not been given any affiliation by AKFI so far.

5. It is further pertinent to note that the applicant Mr. Y. Srikanth had filed Writ Petition No. 237/2019 before Hon'ble High Court of Andhra Pradesh. The Hon'ble High Court in its order dated 25.01.2019 directed the Administrator to consider the representations and rejoinder dated 05.01.2019 and 08.01.2019 in accordance with law. The objections in the said representations were disposed of by an order dated 28.01.2019. It was observed that the applicant had not brought order dated 17.01.2019 to the notice of Hon'ble High Court

while addressing arguments on 25.01.2019. The representations of the applicant were disposed of after consideration by way of order dated 28.01.2019. The applicant has now filed writ petition No. 10431 of 2019 before the Hon'ble High Court of Andhra Pradesh at Amaravati. The Hon'ble High Court vide its order dated 05.08.2019 has granted interim directions as prayed for in I.A No. 1 of 2019. The Administrator has been directed to pass orders on the representations dated 30.03.2019.

After disposal of objections made by Mr. K.P Rao and also considering the representations of the applicant Mr. Y. Srikanth in the rejoinder dated 05.01.2019, a detailed order 17.01.2019 was passed and affiliated body Andhra Kabaddi Association represented by its President Mr. K.E Prabhakar and Secretary Mr. Veeralankaiah were permitted to participate in the election held on 15.02.2019 as the recognised and affiliated unit of AKFI. The said body was, however, directed to amend its Constitution and to hold elections of its Office Bearers within the parameters of NSCI within one month. Apparently the directions to hold election in terms of the order dated 17.01.2019 were to the affiliated unit of AKFI i.e. Andhra Kabaddi Association

represented by its President Mr. K.E Prabhakar and Secretary Mr. Veeralankaiah. This order was not challenged by the applicant and has attained finality. Andhra Kabaddi Association being represented by Mr. K.E Prabhakar and Mr. Veeralankaiah continues to be the affiliated and recognised unit of AKFI. There cannot be two Associations one led by Mr. Veeralankaiah and the other by Mr. Y. Srikanth as its Honorary Secretary. Needless to say election of the Office Bearers of Andhra Kabaddi Association as declared on 23.03.2019 cannot be given effect to grant recognition or affiliation to Andhra Kabaddi Association being represented by Mr. Y. Srikanth as its General Secretary.

- In view of above discussion, the representation dated 30.03.2019 filed by Mr. Y. Srikanth is dismissed.
