Mr. Suranjan Bhattacherya, authorised representative of West Bengal Kabaddi Association was permitted in the meeting in terms of the order dated 06.01.2021 of the Hon'ble Delhi High Court in case titled WEST BENGAL KABADDI ASSOCIATION V/S AMATEUR KABADDI FEDERATION OF INDIA WP(C) 12776/2019.

The meeting was started by the Administrator and a round of introduction took place.

The Administrator started the meeting and welcomed all the members present and wished them a happy and prosperous New Year. The Administrator informed the House that due to pandemic COVID-19, almost all activities of Kabaddi had come to a halt, although online coaching camps were organised by AKFI for players to keep them engaged; some States also conducted online activities. The Administrator also informed the House that the situation of COVID -19 has not yet improved but unlock procedure has started. AKFI wanted to conduct the Referee Examination but due to pandemic, it has been deferred. PKL also could not take place in the year depriving players from its benefits. He also informed that that due to uncertainty no long term plans could be made. The Administrator urged the State bodies where litigations were going on that they should sort out the differences in the best interest of Kabaddi. The Administrator also informed the House that Ministry of Youth Affairs & Sports Govt. of India has issued Standard Operating Procedure (SOP) & Guidelines for Organizing Sports Competitions in the Country in a COVID-19 Environment and AKFI has also drafted SOP for the same. Permission to hold All India Kabaddi Tournament with certain conditions and following of SOP of MYAS and AKFI has been granted to Sahyoug Krida Mandal Shri Dham (Gotegaon) Distt. Narsinghpur M.P. Similarly permission to hold South Zone level Kabaddi Tournaments with certain conditions and following of SOP of MYAS and AKFI has been granted to 1. Elayabharatham Kabaddi Club Kabampoor Salem District, 2. Ya. Othakadai village Elaikargal Madurai District and 3. Kelapavoor Sports Club, Kelapavoor Thenkasi District.

After the deliberations the agenda items were taken up for consideration.

Item No. 1 Finalization of Calendar of 2019-2020 and decision on National Championships

A. Circle Style Kabaddi National Championship

Mr. Sikandar Singh Maluka of Punjab Kabaddi Association proposed to allot Circle Style Kabaddi National Championship to Punjab Kabaddi Association. He also informed that the event will be organised at Talwandi Saboo Distt. Bhatinda. No other proposal to organise Circle Style National Championship was received from any other State.

The matter was discussed in the house and house unanimously decided to allot Circle Style Kabaddi National Championship to Punjab Kabaddi Association.

B. Beach Kabaddi National Championship

Mr. V. Veeralankaiah Andhra Kabaddi Association proposed to organise Beach Kabaddi National Championship in Andhra Pradesh. No other proposal from any other State was received. The matter was discussed in the House and it unanimously decided to allot Beach Kabaddi National Championship to Andhra Kabaddi Association.

C. Sub Junior National Kabaddi Championship

Mr. Chetan Joshi of Uttarakhand Kabaddi Association voluntarily proposed to organise Sub Junior National Kabaddi Championship for Boys & Girls in Uttarakhand. No other proposal by any other unit for Sub Junior National Kabaddi Championship was put before the House. The House unanimously decided to allot Sub Junior National Kabaddi Championship to Uttarakhand Kabaddi Association

D. Junior National Kabaddi Championship

Mr. K. Jagdishwar Yadav of Telengana Kabaddi Association and Mr. Chetan Joshi of Uttarakhand Kabaddi Association voluntarily proposed to organise Junior National Kabaddi Championship for Boys & Girls in their respective States.

The matter was discussed in the House and the House unanimously decided to allot Junior National Kabaddi National Championship for Boys and Girls to Telengana Kabaddi Association.

E. Senior National Kabaddi Championship

Mr. Aswad Patil informed the house that Maharashtra State Kabaddi Association has already sent proposal to AKFI to hold Senior National Kabaddi Championship for Men and Women.

Mr. Rajesh Kumar Singh of U. P. Kabaddi Association also proposed to hold Senior National Kabaddi Championship for Men and Women.

The matter was discussed in the house and house unanimously decided to allot Senior National Kabaddi Championship for Men to U. P. Kabaddi Association and Senior National Kabaddi Championship for Women to Maharashtra State Kabaddi Association.

F. Federation Cup Junior

Mr. B. Kalita of All Assam Kabaddi Association, Mr. Chetan Joshi of Uttarakhand Kabaddi Association and Mr. A. Saffiulla of Tamilnadu Amateur Kabaddi Association proposed to organise Federation Cup Junior for Boys and Girls in their respective States.

The matter was discussed in the House and the House unanimously decided to allot Federation Cup Junior for Boys & Girls to All Assam Kabaddi Association.

G. Federation Cup Senior

Mr. Jitendra Pransingh Thakur of Ameature Kabaddi Association of Vidarbha and Mr. Kumar Vijay Singh of Bihar State Kabaddi Association proposed to organise Federation Cup Senior for Men and Women in their respective states.

The matter was discussed in the house and house unanimously decided to allot Federation Cup Senior for Men & Women to Ameature Kabaddi Association of Vidarbha.

Item No. 2 Any other matter with the permission of the chair

Mr. K. Jagadishwer Yadav of Telengana Kabaddi Association sought permission of the Chair to put forward his suggestions regarding selection of coaches. He stated that AKFI invites applications on the website of the AKFI and no information is given to the State Secretaries, as a result, some good coaches from States in the absence of information are deprived from applying. He suggested that the information should be given to the State Secretaries and only those applications should be entertained which are forwarded by State Secretaries as some coaches who are working against federation are also included in the list of selected coaches.

The Administrator informed the House that the selection of coaches was done on the basis of their Virtual interview and qualification. The Administrator accepted the proposal and assured that information will also be sent to the State Secretaries who in turn may inform the coaches of their states to make proper applications for selection on merits.

Mr. Dattaram Kamat with the permission of Chair informed that in the AGM of 18.06.2019, when the Constitution of AKFI was amended, it was resolved that the coaches who accompanied the Indian Kabaddi Teams for South Asian Games be debarred. The Administrator informed the House that the body was only empowered to amend the constitution as per the judgment of the Hon'ble Delhi High Court so it was beyond the jurisdiction of the body to take any other decision.

Mr. Kuldeep Gupta of Jammu & Kashmir Amateur Kabaddi Association with the permission of Chair raised the issue of the certificates to Coaches and Managers. He also raised the issue of irregular train services in the country due to COVID -19 and the difficulties faced by the teams to travel to the venue of National Championships. The Administrator assured to look into the matter.

Mr. Rajesh Singh of U.P Kabaddi Association with the permission of chair requested for financial assistance to conduct the National Championships. The Administrator informed that in past also AKFI has extended financial assistance to State units and will consider the requests on merits.

Mr. Dinesh Patel of Gujarat State Kabaddi Association with the permission of chair raised the point of nonpayment of ticket money as in the absence of Railway Concessions teams traveled on full ticket. He also requested for affiliation certificate from AKFI. The Administrator assured to look into the matter.

Mr. K. Jagadishwer Yadav of Telengana Kabaddi Association with the permission of chair also raised the point of Observer of AKFI in the elections of State Units and affiliation certificate. The administrator informed the house that if State which is conducting the elections agrees to pay the Travel, Boarding and Lodging Expenses of Observer, AKFI will send the Observer.

Mr. Kuldeep Gupta of Jammu & Kashmir Amateur Kabaddi Association with the permission of chair requested the Administrator to grant financial assistance to the affiliated units to hold the National championships. The administrator asked to send the request and it will be considered on merits.

The Administrator thanked all the members and said that it is their Association and urged that the members must resolve the issues in their respective units. He also informed the House that if any member unit wanted to discuss their individual matter they were free to send the e-mail and the matter can be discussed through Virtual Meeting.

As there was no other matter the meeting ended with vote of thanks to the Chair.
