#### 1. INTRODUCTION

KHELO INDIA - AKFI JUNIOR GIRLS KABADDI LEAGUE aims at strengthening the entire Kabaddi ecosystem to promote the twin objectives of mass participation and promotion of excellence in Kabaddi, particularly Women. It has been introduced to strengthen Kabaddi culture in India at the grass-root level by building a framework for Kabaddi, a sport of Indian origin.

# 3. ELIGIBILITY CRITERIA

This is a BID floated to grant the Sponsorship Rights and Media Rights including Social Media against a fixed Royalty to AKFI for any eligible Individual or Firm or Company with sound financial background. The Minimum turnover of such Individual or Firm or Company should not be less than Rs. 25 crores in last three financial years.

# 4. BID SECURITY / EARNEST MONEY DEPOSIT (EMD)

- 4.1 The Bidder shall furnish along with its Bid, Bid Security for an amount of INR 10,00,000.00 (Rupees Ten Lakh only)
- 4.2 The Bid Security is required to protect AKFI against the risk of the Bidder's unwarranted conduct as amplified under subsequent sections below. Non-submission of bid security will be considered as major deviation. Bid for the project without Bid Security will not be considered.
- 4.3 Bid security must be submitted to AKFI along with the bid.
- 4.4 The Bid Security shall be furnished in one of the following forms:
- a. Account Payee Demand Draft
- b. Banker's cheque

- 4.5 Demand Draft / Bankers Cheque from scheduled commercial bank drawn in favour of "Amateur Kabaddi Federation of India" payable at JAIPUR (Rajasthan) should accompany the Bid.
- 4.6 The Bid Security will be refunded to unsuccessful Bidders without interest within 7 days from the date of opening of the bid.
- 4.7 The EMD can be forfeited if an agency:
- a. Withdraws or amends or impairs or derogates its bid during the period of bid validity.
- b. Fails to accept orders issued in its favour for execution, and / or violates the terms and conditions of the contract after submission of the bid.
- c. Successfully gets qualified, but fails to sign the contract within the stipulated time.
- d. Without prejudice to other rights of AKFI, if it fails to furnish the required Performance Security within

thespecified period.

# 5. BID VALIDITY

- 5.1 The Bid is for one event of KHELO INDIA AKFI JUNIOR GIRLS KABADDI LEAGUE to be conducted in FY 2022-2023 as per mutually agreed dates between the successful bidder, AKFI and SAI.
- 5.2 The event will be in two phase i.e. phase I & Phase II. The venue will be decided on mutually agreed Place and venue between the successful bidder, AKFI and SAI. Approximate days of the event in both phases will be 11 to 15 days. Tentative teams will be 12 each team comprising of 12 players + 1 Coach + 1 manager totaling 14 persons in all. Approximate matches will be 63.

# 6. SIGNING OF BID

6.1 Bid shall be typed and the same shall be signed by the bidder or by a person(s) who has been duly authorized to sign by his/her firm or company. A resolution of such intent be attached to the bid form CLARIFICATION OF BID

# 7. INSTRUCTIONS TO APPLICANTS

#### 7.1 Proposal preparation cost

- The Applicants shall bear all costs associated with the preparation and submission of the Proposal. AKFI will not be responsible and liable for any costs, regardless of the conduct or outcome of the Proposal/process.
- All papers submitted with the Proposal are neither returnable nor claimable.

# 7.2 Right to accept and reject any or all the Proposals

- Notwithstanding anything contained in this BID, AKFI reserves the right to accept or reject any Proposal and to annul the bidding process and reject all the Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, without assigning any reason
- AKFI reserves the right to reject any Proposal if:
- At any time, a material misrepresentation is made or discovered, or
- The Applicant does not adhere to the formats provided in the Annexure(s) to the BID while furnishing the required information / details.

#### 7.3 Data identification and collection

- It is desirable that the Applicants submit their Proposal after verifying the availability of the data, information and/or any other matter considered relevant.
- It would be deemed that by submitting the Proposal, the Applicant has:
- Made a complete and careful examination and accepted the BID in totality;
- Made a complete and careful examination of the various aspects of the Scope of Work.
- AKFI shall not be liable for any mistake or error on the part of the Applicant in respect of the above.

# Preparation and submission of Proposals

# 7.4 Language and currency

- The Proposal and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by the Applicants with the Proposal may be in any other language provided that they are accompanied by appropriate translations of the pertinent passages in the English language. Supporting materials, which are not translated into English, may not be considered for evaluation. For the purpose of interpretation and evaluation of the Proposal, the English language translation shall prevail.
  - The currency for the purpose of the Proposal shall be the Indian National Rupee (INR).
  - Applicants should provide all the information as per the BID and in the specified formats. AKFI reserves the right to reject any Proposal that is not in the specified formats.
  - In case the Applicants intends to provide additional information for which specified space in the given format is not sufficient, it can be furnished in duly stamped and signed.

# 7.5 Submission of bid/Proposal

 The Bid / Proposal with all documents should be sent by post or by Hand so as to reach AKFI Office – E386, Basement Greater Kailash Part 1 New Delhi 110048 on or before last date and time. Bids received late will not be entertained.

#### 7.6 Withdrawal and resubmission of Proposal

- At any point of time, an Applicant can withdraw his / her Proposal submitted before the Proposal Due Date By informing AKFI in writing.
  - From the time the Proposals are opened to the time the contract is awarded, if any Applicant wishes to contact the AKFI, on any matter related to their Proposal it should do so in writing. Any effort by the Applicants to influence any officer or bearer of the AKFI in the Proposal evaluation or contract award decisions may result in the rejection of the Applicant's Proposal.

# 7.7 Opening of Proposals

7.7.1 AKFI will open all bids / Proposals, in the presence of Applicant's representatives who choose to attend on the prescribed date of opening at the AKFI office. The Applicant's representatives who are present shall sign a register evidencing their attendance. In the event of the specified date bid / Proposal opening being declared a holiday for the AKFI, the bids shall be opened at the appointed time and place on the next working day. Working day means the day when the office opens after the holiday for routine work.

# 8. AWARD OF CONTRACT

8.1 AKFI reserves the right to accept/reject a bid, to cancel/abort the BID process and/or reject all bids at any time prior to award of contract, without thereby incurring any liability to the empanelled agencies on the grounds of such actions taken by AKFI.

8.2 AKFI shall award Contract to the highest quoting bidder.

#### 9. PERFORMANCE SECURITY

The Successful bidder will deposit 50% of the Bid Amount within 5 working days to AKFI by way of Demand Draft / Bankers Cheque or RTGS failing which the EMD of the Bidder will be forfeited.

#### **10. INTELLECTUAL PROPERTY**

The bidder must ensure that all intellectual property including but not limited to SAI/ Khelo India/ AKFI logo, creative's any work, brand name, trade name, service mark, trademark etc., related to SAI/ Khelo India/ AKFI shall belong to SAI & AKFI. In no event, the Agency shall, either directly or indirectly, register, file or attempt to register or file any intellectual property in its own name. The winning bidder may use the Khelo India /AKFI Logo only for the intended purpose of naming themselves as Official Sponsor (in that category) to the KHELO INDIA - AKFI JUNIOR GIRLS KABADDI LEAGUE. However, the same may be used only for 120 days after the last day of the events. The Bidder shall be responsible to ensure that the sponsorer does not continue to use the logo beyond 120 days. In case the sponsor is using the logo beyond 120 days, suitable action may be taken against the agency.

The Bidder shall be solely responsible for any violation or infringement of any trademark, trade name, copyright, patent of any person, firm or company, personal right of privacy, religious beliefs and/or any other right of any other person including for adherence of regulations, administrative and judicial orders etc.

The relationship between the parties hereto shall be on a Principal to Principal basis and shall not be deemed to be a joint venture, partnership or agency of any nature whatsoever between them.

Bidder undertakes and confirms that it shall comply with all requisites, laws and regulations, necessary insurances, that are required to be complied with for conducting the event and the creation, as well as exclusive assignment of all rights in favour of AKFI, Agency shall keep AKFI indemnified and hold AKFI harmless from any and all claims including claims for infringement, losses, demands, damages, costs, charges, expenses that may prejudice AKFI's interests and benefits, in any way whatsoever.

AKFI shall not be responsible in any way for any unfulfilled obligations and/or liabilities of Agency its Affiliates/Associations etc. and/or its agents towards any person, party, company, organization in connection with pending obligations, the finance, employment of other contractual and non- contractual.

Agreements/arrangements of whatsoever nature, whether or not in relation to the event and Agency shall continue to be solely responsible for the same

#### **11. PENALTY CLAUSE**

11.1 If the bidder fails to submit the 100% of the bid fee within the stipulated 7 working days after signing of agreement or 15 days before the event whichever is later, a penalty of 0.25% per day will be levied on the 100% of the BID value up to a period of 7 days, if

the remaining BID amount is not paid, after the expiry of 14 days beyond the stipulated period for paying the same or start of the event whichever is later the BID rights will be withdrawn as per the terms and conditions of the agreement, and amount so far paid to AKFI including EMD will be forfeited. AKFI will have right to allot it to any other one.

- 11. 2 AKFI shall be entitled to terminate this contract immediately upon a written notice, in case the Agency is in material breach and/or fail to fulfill its obligations as promised under this agreement provided Agency fails to remedy such breach within 5 days upon notification of the breach.
- 11.3 Any dispute or difference arising between Agency and AKFI shall be mutually resolved through amicable discussions failing which a sole arbitrator as mutually appointed by both the parties, arbitration proceedings would be held under the provisions of Arbitration and Conciliation Act, 1996 as amended. The procedure and fee of the Arbitrator shall be in accordance with prevailing policies and procedures of AKFI. Any dispute / differences not being the subject matter of such arbitration shall be subject to the jurisdiction of the Courts of Law at Delhi only, as per governing laws.
