## Player State Transfer – Applying Process

Applicants are advised to thoroughly review the state transfer process before submitting their application.

### 1. Prepare Declaration Letter

- Fill out the official **Declaration/Undertaking by Player** (as per AKFI format).
- Clearly mention your **current playing state association** and the **state you wish to transfer to**.
- Clearly mention **reason for state transfer**.
- Sign the declaration and get it attested by **two witnesses**.

### 2. Obtain NOC from Releasing State Association

- Request a **No Objection Certificate (NOC)** from your **Releasing State Association**.
- This document confirms that your current state has no objection to your transfer.

### 3. Acceptance from Admitting State Association

- Submit the NOC to the **Admitting State Association** (the state you want to join).
- Obtain their **Acceptance Certificate**, confirming they agree to register you.

### 4. Pay Transfer Fee

- A **transfer fee of ₹700/-** must be paid to AKFI Demand Draft Only in the favour of **Amateur Kabaddi Federation of India, Payable at Jaipur**.
- The DD must be couriered to the registered office of AKFI along with all other documents.

### 5. Submit Application to AKFI

- Compile the following documents:
  - Player Declaration Letter
  - NOC from Releasing State Association
  - Acceptance Certificate from Admitting State Association
  - DD of ₹700/- The transfer fee payment
  - Existing AKFI Player Identity Card
- Submit the complete set to **AKFI Headquarters** or through your state association.
