# Objections to the names sent by Andhra Kabaddi Association (AKA) for preparation of "Electoral College" for holding Second Round of Election of AKFI on 01.09.2019

#### ORDER

- Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
- 2. Andhra Kabaddi Association (AKA), an affiliated unit of AKFI has sent names of its two representatives namely Mr. K.E. Prabhakar President and Mr. V. Veeralankaiah General Secretary of the Association. Besides this two more names have also been received and these names are Mr. G. Venkata Reddy and Mr. Y. Srikanth who claim themselves to be the President and Secretary elected on 23.03.2019 in an election conducted by Justice DSR Verma, Former Judge of Andhra Pradesh High Court.

A representation dated 30.03.2019 was made by Mr. Y. Srikanth praying for issue of affiliation / recognition to Andhra Kabaddi Association represented by him as its General Secretary and Mr. G. Venkata Reddy as its President. The said representation has been disposed of by an order dated 07.08.2019 with an observation that Andhra Kabaddi Association being represented by Mr. K.E. Prabhakar and Mr. V. Veeralankaiah continues to be the affiliated and recognised unit of AKFI. Since there could not be two Associations, one led by Mr. V. Veeralankaiah and the other by Mr. Y. Srikanth as its Honorary Secretary, election of Office Bearers of Andhra Kabaddi Association as declared on 23.03.2019 could not be given effect to grant recognition and affiliation to Andhra Kabaddi Association represented by Mr. Y. Srikanth as its General Secretary.

3. It is relevant to observe that at the time of conducting First Round of Election of AKFI on 15.02.2019, AKA had sent names of Mr. K.E. Prabhakar and Mr. V. Veeralankaiah to participate in the elections. Objections received against those two names were decided after giving hearing to both sides by a comprehensive order dated 17.01.2019. The order was put on the website of AKFI and was

conveyed to objectors by email. In the said order it was specifically observed that for the purpose of conducting First Round of Election to elect the Office Bearers to amend the MOA of AKFI, names sent by Andhra Kabaddi Association of Mr. V. Veeralankaiah and Mr. K.E. Prabhakar were to be accepted.

- 4. It is relevant to note that Andhra Pradesh Association represented by its General Secretary Mr. Y. Srikanth had filed writ petition No. 46681 of 2018 before the High Court of Andhra Pradesh. The said writ petition No. 46681 of 2018 in terms of the order passed by Administrator, was disposed of by a judgment dated 13.03.2018. Seemingly the Andhra Kabaddi Association (AKA) has not conducted elections in terms of the order of the Hon'ble High Court.
- 5. It is true that there are several serious allegations against Mr. V. Veeralankaiah, the Honorary Secretary of Andhra Pradesh Association. It was informed that Mr. V. Veeralankaiah was arrested in an FIR lodged by certain women players for molestation. Keeping the said aspect in mind, 66<sup>th</sup> Senior National Kabaddi Championship Women was not allotted to Andhra Kabaddi Association. It has also been brought to our notice that an enquiry was conducted against

Mr. V. Veeralankaiah and it has again against him. It is also on record that at the time of participation in the 66<sup>th</sup> Senior National Kabaddi Championship Women held at Patna from 11<sup>th</sup> to 14<sup>th</sup> July 2019, Mr. V. Veeralankaiah had sent its own team. Mr. Y. Srikanth and several players who were not members in the team sent by Mr. V. Veeralankaiah had approached the Hon'ble High Court. The Hon'ble High Court had directed Sports Authority of Andhra Pradesh to select the players.

6. It is on record that Mr. Y. Srikanth has filed another writ petition No. 10431/2019 before the Hon'ble High Court of Andhra Pradesh at Amaravati seeking affiliation and recognition to participate in the Second Round of Election. The said writ petition is pending before the Hon'ble High Court and is listed for 03.09.2019. No interim directions have been granted for participation and recognition to Andhra Pradesh Kabaddi represented by Mr. Y. Srikanth. In I.A No. 1 of 2019 interim directions were granted to pass orders on the representation dated 30.03.2019 made by Mr. Y. Srikanth for affiliation and recognition. The said representation had since been decided by the Administrator by an order dated 07.08.2019 and its

copy has been sent to Mr. Y. Srikanth as well as Registrar General of Hon'ble High Court of Andhra Pradesh.

- 7. Despite all the allegations and various litigations pending against Mr.

  V. Veeralankaiah, the Honorary Secretary of Andhra Kabaddi
  Association, no orders have been passed by the Court / Authority to
  remove him from the post of Secretary, Andhra Kabaddi Association.

  No Association represented other than Mr. K.E. Prabhakar as its
  President and Mr. V. Veeralankaiah as its Secretary has been granted
  any recognition so far. The matter is already sub judice before the
  Hon'ble High Court of Andhra Pradesh at Amaravati. The objector is
  been well advised to seek requisite relief as per law from the Hon'ble
  High Court for recognition and affiliation.
- 8. As per the Constitution of AKFI and the Model Election Guidelines the "Electoral College" is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.
- Since Andhra Kabaddi Association led by Mr. G. Venkata Reddy and Mr. Y. Srikanth is not the affiliated Unit / Member of AKFI, names sent by it of Mr. G. Venkata Reddy and Mr. Y. Srikanth to attend the
