**Objections to the names sent by Kerala Kabaddi Association (KKA) for
preparation of “Electoral College” for holding Second Round of Election of
AKFI on 01.09.2019**

ORDER

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of “Electoral College”.
2. Kerala Kabaddi Association (Regd. No. 335/88) (KKA) continues to be the affiliated Unit / Member of AKFI. By email dated 11.08.2019 at 6:55 pm, names of Mr. M. Sudheer Kumar and Mr. K K Muralidharan were received sent by President Mr. M. Sudheer Kumar. By another email dated 13.08.2019 at 12:55 pm, names of Mr. M. Sudheer Kumar President and Mr. K. Vijayakumar Secretary Kerala Kabaddi Association were received purportedly signed by both the President and Secretary of KKA. Registered letter dated 11.08.2019 was also

received by post whereby Mr. M. Sudheer Kumar President Kerala Kabaddi Association sent two names i.e. Mr. M. Sudheer Kumar and Mr. K K Muralidharan. Another registered letter dated 12.08.2019 has been received from Mr. K. Vijayakumar, Secretary Kerala Kabaddi Association (KKA) sending names of Mr. M. Sudheer Kumar and Mr. K. Vijayakumar, President and Secretary of Kerala Kabaddi Association respectively. It also bears signatures of the President.

3. Email dated 17.08.2019 has been received from Mr. M. Sudheer Kumar, President Kerala Kabaddi Association (KKA) whereby he has stated that authorised representative would be Mr. M. Sudheer Kumar President and Mr. K K Muralidharan Secretary. It further states that names sent by Mr. K. Vijayakumar be rejected.
4. As per AKFI record Mr. M. Sudheer Kumar continues to be the President of Kerala Kabaddi Association and Mr. K. Vijayakumar to be its Secretary. No intimation was received from Kerala Kabaddi Association whereby the elections were conducted by Kerala Kabaddi Association on 10.03.2019 in which Mr. K K Muralidharan was elected as its Secretary. The detailed proceedings of the election purportedly conducted on 10.03.2019 have not been sent to AKFI. Only vide email

dated 17.08.2019 certain documents have been received showing election of KKA on 10.03.2019.

5. It is relevant to note that there is dispute between the President and Secretary of KKA since long. At the time of selection of teams for participation in various championships also both Mr. M. Sudheer Kumar and Mr. K. Vijayakumar had sent two different teams. The matter was brought to the Hon'ble High Court. The final orders in the said proceedings have not been produced before AKFI. To reconcile the interest of the players, selection was made from the players of both the two teams. For participation in 66th Senior National Kabaddi Championship held at Patna from 11th to 14th July 2019, Sports Council of Kerala was requested to send the team for Kerala.
6. As per the Constitution of AKFI the President and Secretary of the affiliated units are to participate in the election. In case they are unable to participate themselves, any of them i.e. President and Secretary can nominate two members. In case of dispute, names sent by the President are to be accepted. In the present case Mr. M. Sudheer Kumar and Mr. K. Vijayakumar are President and Secretary of Kerala Kabaddi Association as per the record of AKFI and they both



intend to participate in the election themselves. In view of this, name of Mr. K K Muralidharan nominated by Mr. M. Sudheer Kumar in place of Mr. K. Vijayakumar cannot be accepted.

7. In view of above names of Mr. M. Sudheer Kumar and Mr. K. Vijayakumar, President and Secretary be included in the "Electoral College" for participation in the Second Round of Election of Office Bearers of AKFI.
