Objections to the names sent by Union Territory of Pondicherry Kabaddi Association (UTPKA) for preparation of "Electoral College" for holding Second Round of Election of AKFI on 01.09.2019

ORDER

- Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
- 2. Union Territory of Pondicherry Kabaddi Association, an affiliated unit of AKFI has sent names of its two representatives namely Mr. A. Djeramane and Mr. A. Jayakumar of the Association. Against these two names, we have received two other names of Mr. D. Vincent Raj and Mr. R. Manavalan from Puducherry Union Pradesa Thamizh Kabaddi Sangam (PUPTKS) and further complaint of Mr. M. Shivakumar from 'Union Territory of Pondicherry Kabaddi Association (UTOPKA)' to ignore the false statements and documents from the anti association and consider the old

and traditional 'Union Territory of Pondicherry Kabaddi Association (UTOPKA)' has been received.

- 3. It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Union Territory of Pondicherry Kabaddi Association sent names of Mr. G. Ariasamy and Mr. A. Jayakumar to participate in the elections. Against those two names objections were filed by Mr. D. Vincent Raj. These objections were heard on 20.12.2018. On behalf of the objectors Mr. D. Vinvent Raj had appeared. Those objections were decided by a detailed order dated 21.01.2019. The names sent by UTPKA were accepted for the limited purpose of preparation of "Electoral College" to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon'ble Delhi High Court.
- 4. The objectors have not challenged the order dated 21.01.2019. It is relevant to note that Mr. M. Shivakumar had filed writ petition No. 1934/2019 and W.MP No. 2152/2019 which were withdrawn by him by an order dated 22.02.2019. It is further relevant to note that that one writ petition No. 1925 of 2019 was filed regarding election of the UTPKA to be held on 27.01.2019 for the year 2019-2023 before Hon'ble High Court of Chennai. The Hon'ble High Court had directed not to declare the results till further orders. The results were declared on 20.01.2019 as there was no

contest. No subsequent order has been produced on record by the petitioner therein. The objector is well advised to approach the Hon'ble High Court of Chennai to seek necessary relief.

- 5. UTPKA led by Mr. V. Chanemogame President and Mr. V. Deivasigamany General Secretary continues to be the affiliated unit of AKFI. PUPTKS led by Mr. M. Nagathiyagarajan and Mr. D. Vincent Raj has not yet been recognised as the affiliated unit of AKFI.
- 6. As per the Constitution of AKFI and the Model Election Guidelines the "Electoral College" is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.
- 7. Since PUPTKS led by Mr. M. Nagathiyagarajan and Mr. D. Vincent Raj are not the affiliated Unit / Member of AKFI names sent by them of Mr. D. Vincent Raj and Mr. R. Manavalan to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names sent by PUPTKS are rejected.
