**Objections to the names sent by Rajasthan State Kabaddi Association  
(RSKA) for preparation of "Electoral College" for holding Second Round of  
Election of AKFI on 01.09.2019**

**ORDER**

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
2. Rajasthan State Kabaddi Association (RSKA) represented by Mr. Tejasvi Singh as its President continues to be the affiliated Unit / Member of AKFI. Mr. Tejasvi Singh President of RSKA has sent names of two authorised persons by email / speed post dated 12.08.2019 for participation in the Second Round of Election on 01.09.2019. The names are Mr. Tejasvi Singh and Mr. Narendra Kumar Summarwar.

We have also received two names i.e. Mr. Tejasvi Singh and Mr. Govind Narayan Sharma sent by Mr. Govind Narayan Sharma by registered letter dated 13.08.2019 to be the authorised representatives to attend the AGM on 01.09.2019. In the letter dated 13.08.2019 Mr. Govind Narayan Sharma claims himself to be the Honorary Secretary of Rajasthan State Kabaddi Association. Relying on the order dated 05.04.2019 in S.B Civil Writ Petition No. 5495/2019 Mr. Govind Narayan Sharma V/s Union of India, he states that till the disposal of the said writ petition, he continues to be the General Secretary of the Rajasthan State Kabaddi Association.
4. Objections have been received on 17.08.2019 from Mr. Tejasvi Singh informing that vide email dated 27.06.2019, it was informed that Mr. Govind Narayan Sharma, the then Honorary Secretary of Rajasthan State Kabaddi Association (RSKA) has been removed by the General Body of the Rajasthan State Kabaddi Association by adopting “No-Confidence Motion” in an Extra Ordinary General Body Meeting dated 23.06.2019.
5. It is further informed that Mr. Govind Narayan Sharma had challenged the resolution of “No-Confidence Motion” before the

Hon'ble Rajasthan High Court in S.B. Civil Writ Petition No. 11238/2019 to get the decision quashed. The said writ petition was dismissed. Again Mr. Govind Narayan Sharma approached Double Bench in D.B. SAW No. 11391/2019 and the said motion was also dismissed. Thereafter Mr. Govind Narayan Sharma had filed an application under section 9 of the Arbitration and Conciliation Act 1996 before the District Judge Jaipur and it has been dismissed vide order dated 13.08.2019.

6. Considering the fact that Mr. Govind Narayan Sharma has been removed from the post of Honorary Secretary of Rajasthan State Kabaddi Association in a "No-Confidence Motion" in an Extra Ordinary General Body Meeting on 23.06.2019 and the challenge to the said removal before the Hon'ble Rajasthan High Court did not succeed the name of Mr. Govind Narayan Sharma as Honorary Secretary of Rajasthan State Kabaddi Association cannot be considered to be included in the "Electoral College" for participation in the Second Round of Election.
7. In view of above, the names sent by Mr. Tejasvi Singh i.e. Mr. Tejasvi Singh and Mr. Narendra Kumar Summarwar be included in the
