Objections to the names sent by Amateur Kabaddi Association of Vidarbha (AKAV) for preparation of "Electoral College" for holding Second Round of Election of AKFI on 01.09.2019

ORDER

- Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
- 2. Amateur Kabaddi Association of Vidarbha, an affiliated unit of AKFI has sent names of its two representatives namely Mr. Ashokrao A. Deshmukh and Mr. Jintendra P. Thakur of the Association. Against these two names, we have received two other names of Mr. Pradipsingh Thakur and Mr. Shirish Kale from 'New Kabaddi Association Vidarbha Sangha, Nagpur'.
- 3. It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Amateur Kabaddi

Association of Vidarbha sent names of Ashokrao A. Deshmukh and Mr. Jintendra P. Thakur to participate in the elections. Against those two names objections were filed by Mr. Subhash Narayanrao Pise, Mr. Nanuram Mohan Lal Verma, Mr. Gunesh Tayade and Mr. Pradeep Singh Thakur. Those objections were heard on 28.12.2018. On behalf of the objectors Mr.Raman Khare and Mr. Sanket R Charpe and Mr. Ganesh Tayde had appeared. Those objections were decided by a detailed order dated 22.01.2019. The names sent by AKAV were accepted for the limited purpose of preparation of "Electoral College" to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon'ble Delhi High Court.

4. The objectors have not challenged the order dated 22.01.2019. AKAV led by Mr. Mr. Ashokrao A. Deshmukh President and Mr. Jintendra P. Thakur General Secretary continues to be the affiliated unit of AKFI. 'New Kabaddi Association Vidarbha Sangh Nagpur' led by Mr. Pradeep Singh Thakur and Mr. Shirish Kale has not yet been recognised as the affiliated unit of AKFI.

Accordingly, the names sent by 'New Kabaddi Association Vidarbha Sangh Nagpur' are rejected.
