## In the office of Amateur Kabaddi Federation of India (AKFI) E-386 Basement Greater Kailash Part 1 New Delhi – 110 048

In the matter of names of Representatives of Tripura Kabaddi Association (TKA) represented by President Mr. Rupak Debroy and Secretary Mr. Ajit Kumar Bhaumik.

## **ORDER**

- AKFI has received names of Mr. Rupak Debroy and Mr. Ajit Kumar Bhaumik from TKA seeking inclusion in the 'Electoral College' of AKFI for the election of Office Bearers going to be held on 24.12.2023.
- 2. Objections have been received from All Tripura Players Forum.
- The objectors have objected on inclusion of the names of Mr. Rupak Debroy and Mr.
   Ajit Kumar Bhaumik in the 'Electoral College' of AKFI for the election of Office Bearers going to be held on 24.12.2023.
- 4. Earlier the names of Mr. Rupak Debroy and Mr. Ajit Kumar Bhaumik were included in the 'Electoral College' of AKFI for the election of Office Bearers going to be held on 07.05.2023.
- 5. It is informed that FIR No. 2023/EAG/157 dated 26.10.2023 u/s 420,506,409, 468, 471 of IPC has been registered at P.S East Agartala against Mr. Rupak Debroy and his anticipatory bail application has been rejected by the Hon'ble High Court of Tripura vide order dated 24.11.2023 in AB 35/2023.
- 6. The comments were asked from Mr. Rupak Debroy vide email dated 04.12.2023. He has stated that no charge sheet has been given to him and he will avail the legal remedy before Hon'ble Supreme Court of India.
- 7. The Administrator / President of AKFI is of the view that TKA continues to be an affiliated unit of AKFI. Mr. Hulu Pal as Secretary of TKA with Mr. Rupak Debroy as President, had no grievance against him before his exclusion.
- 8. The names given by All Tripura Players Forum for formation of committee to be headed by Mr. Litan Roy as President and Mr. Hulu Paul as Secretary and Mr. Bijay Krishna Das as Treasurer and inclusion of their names in the 'Electoral College' cannot be considered for the election of Office Bearers going to be held on 24.12.2023.
- 9. The objections are dismissed.



- 10. The objectors may take recourse to legal remedies as available to them.
- 11. The inclusion of the name of Mr. Rupak Debroy shall be subject to the outcome of the FIR 2023/EAG/157 dated 26.10.2023 at P.S East Agartala and also WP(C) 5803/2023.
